ORDER CANCELING PROCEDURAL SCHEDULE

Effective Date: March 9, 2023

On September 16, 2022, Charles Harter filed a complaint against Missouri-American Water Company. On December 14, 2022, the Commission issued its *Order Setting Procedural Schedule*. On February 9, 2023, the Commission granted Mr. Harter’s request for a change of the scheduled evidentiary hearing date and directed the filing of a revised proposed procedural schedule. A revised proposed procedural schedule was filed on February 23, 2023, but due to developing scheduling needs, the date of the evidentiary hearing was twice further requested to be revised.¹ On March 7, 2023, the Commission ordered a proposed procedural schedule to further account for the Commission’s scheduling needs and the developing scheduling needs of the parties.

On March 8, 2023, Staff filed a *Motion for Extension of Time* referencing the original *Order Setting Procedural Schedule* issued on December 14, 2022.

Rather than granting Staff’s request for an extension of time, the Commission will specify that the procedural schedule it issued on December 14, 2022, is canceled. The Commission’s order of March 7, 2023, which directs a new proposed procedural schedule

to accommodate the Commission's and parties' scheduling needs to be submitted no later than March 17, 2023, is still applicable.

THE COMMISSION ORDERS THAT:

1. The procedural schedule set by Commission order on December 14, 2022, is canceled.
2. Staff's request for an extension under the procedural schedule issued on December 14, 2022, is moot.
3. This order shall be effective when issued.
