On September 16, 2022, Charles Harter filed a complaint with the Missouri Public Service Commission against Missouri-American Water Company (MAWC). On May 31, 2023, Mr. Harter filed a notice of settlement and request to withdraw complaint, dismissing his case against MAWC without prejudice.
