SECOND ORDER SETTING PROCEDURAL SCHEDULE

Issue Date: May 3, 2023

Effective Date: May 3, 2023

On March 7, 2023, the Commission issued an order directing the Staff of the Commission (Staff) to file a proposed procedural schedule to replace the original procedural schedule in this matter no later than March 17, 2023. On March 17, 2023, in response to the Commission's order, Staff filed its *Second Revised Joint-Proposed Procedural Schedule*. In its joint-proposed schedule, Staff states that the parties request the hearing commence in the afternoon in Jefferson City and that the Complainant, Mr. Harter, be allowed to attend the hearing by telephone.

Because of a Commission conflict on June 20, the Regulatory Law Judge consulted with the parties and the hearing date will be changed to June 27, 2023. After reviewing the proposed procedural schedule, the Commission concludes that the schedule proposed by the parties is otherwise reasonable and should be adopted.

THE COMMISSION ORDERS THAT:

1. The following procedural schedule is established:

May 16, 2023	Discovery Deadline
May 23, 2023	Joint List of Issues, List and Order of Witnesses, Order of Cross-Examination, and Order of Opening
May 30, 2023	Statement of Positions on the Issues
June 27, 2023	Evidentiary Hearing

2. The Commission shall hold an evidentiary hearing on June 27, 2023, beginning at 1:30 p.m.

3. The hearing shall be held at the Commission's office at the Governor Office Building, Room 310, 200 Madison Street, Jefferson City, Missouri. This building meets accessibility standards required by the Americans with Disabilities Act. 4. Parties and witnesses may appear in person, remotely via WebEx, or telephonically. Telephone numbers for parties appearing by telephone will be provided prior to the hearing date.
