ORDER GRANTING REQUEST FOR EXTENSION

On December 28, the Commission issued its Order Directing Answer to Complaint, directing Raytown Water Company (Raytown) to respond the complaint filed by Jocelyn Lewis, and directing the Staff of the Commission (Staff) to file its report and recommendation no later than January 18, 2023.

On January 18, Staff filed its request to extend the deadline for its report and recommendation for 30 days because it requires more time to analyze data request responses. Staff states that neither Ms. Lewis, Raytown, nor the Office of the Public Counsel objects to a 30-day deadline extension.

The Commission will grant Staff's request for an extension of time to submit its report and recommendation.

THE COMMISSION ORDERS THAT:

1. Staff's request for a 30-day extension to file its report and recommendation is granted.

2. Staff shall file a report detailing its findings and recommendations no later than February 17, 2023.

3. This order shall be effective when issued.
