## PUBLIC COUNSEL'S RESPONSE TO STAFF RECOMMENDATION

COMES NOW the Office of the Public Counsel (Public Counsel) and for its Response to Staff Recommendation states as follows:

- 1. On December 4, 2007, Staff of the Missouri Public Service Commission (Staff) filed its Staff Recommendation regarding the Missouri-American Water Company (Missouri-American) application seeking an expansion of its service territory to authorize it to provide water and sewer service in a subdivision in Jefferson County known as Paradise Valley.
- 2. In its filing, Staff recommended that the Missouri Public Service Commission (Commission) issue an order granting Missouri-American's request for a certificate of convenience and necessity to provide water and sewer service to the proposed service area.
- 3. The Staff also recommended that the Commission approve a connection charge of \$1,550 per new connection in Paradise Valley plus a surcharge of \$15 per month upon all customers in Paradise Valley, with said connection charge and surcharge to remain in effect until such time as Missouri-American recovers all of its new investment in Paradise Valley that is in excess of \$400,000.

- 4. The Staff made other recommendations as set forth on pages 6 and 7 of its attached Staff Memorandum.
- 5. Office of Public Counsel has reviewed the Staff Recommendation and does not object to its recommendations to the Commission.

**WHEREFORE,** Public Counsel respectfully submits that it has no objections to the Staff Recommendation.
