COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and hereby submits this *Staff's Compliance Tariff Recommendation*.

- 1. On May 9, 2018, the Commission issued its *Report and Order* in the above-styled case. The *Report and Order* directed Gascony Water Company, Inc. (Gascony Water) to file tariffs, among other things, consistent with the *Report and Order* by no later than May 29, 2018.
 - 2. On May 22, 2018, Gascony Water filed its compliance tariffs.
- 3. On May 23, 2018, the Commission directed Staff to file a recommendation as to whether the tariffs complied with the directives in the *Report and Order* by no later than June 4, 2018.
- 4. The compliance tariffs are a complete replacement of P.S.C. Mo. No 1 with P.S.C. Mo. No. 2. Staff and Gascony Water agreed to this replacement in the Partial Disposition Agreement, which the Commission subsequently approved in its *Report and Order*. The new tariff reflects the current rules and regulations of the Commission (including recent changes made to Chapter 13). Without an update, the Company's prior tariff would conflict with changes to the rule.

5. After review, Staff concludes that the filings comply with the Commission's Report and Order. Thus, Staff <u>recommends approval</u> of:

P.S.C. Mo. No. 2 cancelling P.S.C. Mo. No. 1

Original Sheet No. 1 through Original Sheet No. 40

WHEREFORE, Staff prays that the Commission will approve the filed compliance tariffs, and grant such other and further relief as the Commission considers just in the circumstances.
