On August 13, 2018, Ozark Mountain Condominium Association, Inc. ("OMCA") filed a motion to have its witness, Don Allsbury, appear at the evidentiary hearing on this matter via telephone. In support of its motion OMCA states that "OMCA's witness, Mr. Allsbury, is the manager of Ozark Mountain Resort, the vacation resort property at Tablerock Lake where the condominium units associated with OMCA are located. Because he manages a resort property, summer Fridays are especially busy workdays for Mr. Allsbury." OMCA also states that it has corresponded with the other parties via email who consent to OMCA's request. The Commission will grant the request for Don Allsbury to appear at the evidentiary hearing via telephone.

THE COMMISSION ORDERS THAT:

1. Don Allsbury shall appear at the evidentiary hearing in this matter via telephone. He shall be available by telephone from 3:00 p.m. on August 16, 2018, until excused. Counsel for OMCA shall provide the regulatory judge with a telephone number for Don Allsbury prior to the start of the hearing.


