ORDER GRANTING MOTION TO STAY PROCEEDINGS

On October 17, 2017, Highway H Utilities, Inc. ("Highway H") filed a *Motion to Stay Proceedings* requesting the Commission stay any action resulting from the Commission's September 19, 2017 *Order Granting Motion for Default Determination*. After the Commission's September 19, 2017 Order was issued, Highway H filed applications with the Commission requesting authority to sell its water and wastewater systems to the City of Waynesville and to Pulaski County Sewer District Number 1.

The Commission issued an order setting a deadline for parties to oppose Highway H's *Motion to Stay Proceedings*, but no responses were filed. The Commission will grant Highway H's Motion.

THE COMMISSION ORDERS THAT:

1. Highway H Utilities, Inc.'s *Motion to Stay Proceedings* is granted.

2. The Commission's Office of the General Counsel shall stay all actions taken to comply with the Commission's September 19, 2017 *Order Granting Motion for Default Determination* until the Commission orders otherwise.

3. No later than February 14, 2018, the Commission's Staff shall file a report stating the status of the transfer applications submitted by Highway H Utilities, Inc.

4. This order shall be effective when issued.
