The Commission directed a response from Carl R. Mills Water Service d/b/a Carl Richard Mills to Complainant's motion for summary determination by December 6, 2021. The Commission permitted other responses by the same date.

On December 1, 2021, Carl R. Mills Water Service filed its *Stipulated Motion for Extension of Time to Respond to Motion for Summary Disposition* which requests a sixty-day extension. Respondent's motion states there is a separate Commission action to transfer ownership of the subject water system (WM-2022-0144), which was requested by Mr. Morgan. Respondent offers that the complaint may be resolved within the timeframe of the requested extension. Respondent also avers that Mr. Morgan does not oppose this request for extension.

The Commission finds the unopposed request to be reasonable and will grant the extension of time for Carl R. Mills Water Service to file its response. The Commission will also extend the deadline for other parties wishing to respond to Mr. Morgan's motion for summary determination.

THE COMMISSION ORDERS THAT:

1. Carl R. Mills Water Service shall file a response to the motion for summary

determination on or before February 7, 2022.

2. Any other party wishing to file a response to the motion for summary determination shall do so on or before February 7, 2022.
