ORDER DIRECTING FILING OF STATUS REPORT

On March 18, 2022, the Commission issued an *Order to Respond to Request for Mediation and Granting Motion to Suspend Deadline*. The order directed Complainant Ralph Rudolph to respond by March 28, 2022 and state whether he consents to participate in mediation, as requested by Missouri-American Water Company (MAWC). To date, Mr. Rudolph has not filed a response to the Commission's order.

On March 30, 2022, MAWC filed a *Status Report* in which it informed the Commission that MAWC personnel have been in contact with Mr. Rudolph concerning possible settlement, but additional time is needed for completion of the process. MAWC requests that the Commission continue to allow the deadlines in this case to remain suspended and to direct the parties to file a status report by April 13, 2022, unless the case has otherwise been resolved by that date.

The Commission will grant MAWC's request.

THE COMMISSION ORDERS THAT:

1. MAWC shall file a joint status report on behalf of itself and the other parties by April 13, 2022, unless the case has otherwise been resolved by that date.
2. This Order shall be effective when issued.
