## ORDER GRANTING REQUEST FOR EXTENSION OF TIME

Issue Date: February 22, 2022 Effective Date: February 22, 2022

On December 16, 2021, Ralph Rudolph filed a formal complaint with the Commission against Missouri-American Water Company (MAWC).

On December 17, 2021, the Commission directed the Staff of the Commission (Staff) to investigate the complaint and file a report or a request for an extention of time within which to file the report no later than February 15, 2022.

On February 15, 2022, at the request of Staff and with the consent of all parties, the Commission extended the deadline for Staff to investigate the complaint and file a report to no later than February 22, 2022.

On February 18, 2022, Staff requested that it be given until March 1, 2022, to file its report, citing the need for more time to analyze water meter testing data. Staff states that MAWC and the Office of Public Counsel consent to the extension and that Mr. Rudolph did not respond when asked about the extension.

Given that water meter accuracy is a central issue of Mr. Rudolph's complaint, the Commission finds good cause to grant a second extension of the deadline for Staff to file its report and recommendation.

#### THE COMMISSION ORDERS THAT:

- 1. Staff's request for an extension of the deadline to file its report and recommendation is granted. Staff shall file its report and recommendation no later than March 1, 2022.
  - 2. This Order shall be effective when issued.
