**ORDER DIRECTING THE FILING OF A
PROPOSED PROCEDURAL SCHEDULE**

On November 13, 2022, I-70 Mobile City Park filed a motion for summary determination. On December 21, 2022, the Commission issued an order staying that summary determination motion pending a resolution of Cole County Circuit Court case 22AC-CC05836. On January 29, 2023, the Circuit Court of Cole County issued its *Order and Judgment* enforcing the Commission’s July 27, 2022, *Order Granting Staff's Motion to Compel and Denying Respondent's Request for a Protective Order*. The Circuit Court’s order directed I-70 Mobile City Park to permit the Staff of the Commission (Staff) to inspect the water and sewer systems on I-70 Mobile City Park’s property. On February 17, 2023, Staff filed a notice that the property would be inspected on March 8, 2023.

The Commission will direct the parties to file a joint proposed procedural schedule including dates for an evidentiary hearing, a last date to issue discovery requests, and a date by which Staff believes it can respond to I-70 Mobile City Park’s summary determination motion. If the parties are unable to agree on specific dates they may file separate proposed procedural schedules and the Commission will determine dates.

THE COMMISSION ORDERS THAT:

1. The parties shall file a joint proposed procedural schedule no later than March 30, 2023.
2. This order shall be effective when issued.
