**JOINT PROPOSED PROCEDURAL SCHEDULE**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned counsel, and on behalf of Complainant, Eric Larson, and submits to the Missouri Public Service Commission (Commission) the following *Joint Proposed Procedural Schedule*:

1. On June 27, 2011, Eric C. Larson (Larson) filed a formal complaint with the Commission against Woodland Manor Water Company (Woodland Manor).

2. Woodland Manor filed a Response to the Complaint on July 21, 2011 and, upon further direction from the Commission, its attorney, Gregory Gibson, entered his appearance and filed an Answer on August 5, 2011.

3. On August 11, 2011, Staff filed its *Recommendation and Report*.

4. On August 30, 2011, a pre-hearing conference was held in which the parties determined that this matter should proceed to hearing with live testimony.

5. Larson and Staff propose the following Procedural Schedule:

Discovery Deadline (Answers Provided by)	October 20, 2011
Joint Stipulation of Undisputed Facts	October 31, 2011
Evidentiary Hearing	November 7-8, 2011

(though parties anticipate a single day hearing)

6. Staff counsel received permission to file this on behalf of Mr. Larson.
7. Staff counsel made several attempts to gain approval from Respondent's attorney, but never received a response regarding this filing. Therefore, Staff counsel cannot state that it files this document on behalf of Respondent.

**WHEREFORE**, Staff respectfully submits this *Joint Proposed Procedural Schedule* on behalf of Staff and Complainant, Eric Larson, for the Commission's information and consideration, and respectfully request the Commission issue an order establishing a procedural schedule for this matter.
