**JOINT PROPOSED PROCEDURAL SCHEDULE**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through its undersigned counsel, and files this *Joint Proposed Procedural Schedule* with the Missouri Public Service Commission ("Commission"), respectfully stating the following in support thereof:

1. On December 19, 2012, the Commission issued an order directing Staff to work with the parties and develop a proposed procedural schedule so that this matter may proceed to an evidentiary hearing.

2. Staff, Marcia Eason ("Complainant"), and Missouri-American Water Company ("MAWC") have reached an agreement on the proposed procedural schedule, as follows with all dates reflecting calendar year 2013:

- Discovery Deadline (Answers provided by): Wednesday, February 6
- Pre-hearing Conference (Discovery issues): Wednesday, February 13 (9:00 AM)
- Joint List of Issues and Witness List: Friday, February 15
- Joint Stipulation of Undisputed Facts: Friday, February 22
- Evidentiary Hearing (Live testimony): Wednesday, March 13\*\*

\*\* The hearing is expected to last one day. \*\*

3. Regarding the timing of the Prehearing Conference, Staff notes that Complainant prefers a time in the early morning, due to her work schedule; and, in Staff's experience, 9:00 am is conducive to Complainant's work schedule.

4. Staff counsel received permission to file this on behalf of the Complainant and MAWC.

**WHEREFORE**, Staff respectfully submits this *Joint Proposed Procedural Schedule* on behalf of Staff, MAWC, and the Complainant, for the Commission's information and consideration; and, Staff respectfully request the Commission issue an order establishing a procedural schedule for this matter.
