**APPLICATION FOR INTERVENTION OF ONEOK
ENERGY MARKETING COMPANY**

COMES NOW ONEOK Energy Marketing Company, pursuant to 4 CSR 240-2.075, and for its Application for Intervention in this case, states as follows:

1. ONEOK Energy Marketing Company (“ONEOK”) is a subsidiary of ONEOK, Inc., which is a diversified energy company headquartered in Tulsa, Oklahoma. ONEOK is a retail natural gas marketer, with offices located in Oklahoma, Kansas, Texas, Nebraska and Wyoming. ONEOK provides gas supply to commercial and industrial customers (including schools, colleges and hospitals) on Missouri Gas Energy’s (“MGE”) system.
2. On April 2, 2009, MGE filed proposed tariffs with the Commission to increase revenues on an annual basis approximately \$32.4 million. MGE also proposes numerous changes to its various tariff provisions.
3. In particular, MGE has proposed changes to certain transportation tariffs that may affect ONEOK. ONEOK’s interest in this case is different than that of the general public.
4. For purposes of 4 CSR 240-2.075(2), ONEOK states that it is generally opposed to tariffs that are unjust, unreasonable and potentially discriminatory. Due to the early nature of this proceeding, ONEOK is unable to state its position relating to the relief sought by MGE. ONEOK is continuing to review MGE’s filing and reserves the right to take positions on specific issues as this case proceeds.


