**ORDER GRANTING MOTION FOR EXTENSION**

Effective Date: April 20, 2017

Terre Du Lac Utilities submitted a request to increase its water and sewer system revenues on October 11, 2016. On April 20, 2017, the Staff of the Missouri Public Service Commission filed a *Motion for Extension* requesting a 15-day extension of the Small Rate Case Timeline. Staff states that the additional 15 days are needed for the parties to continue negotiating a few outstanding issues. Staff previously requested, and was granted, both a 30-day extension and a 15-day extension. Pursuant to Commission Rule 4 CSR 240-3.050(12), Staff and Terre Du Lac Utilities can agree to extend the Small Rate Case Timeline up to 60 days.

Staff and Terre Du Lac have agreed to this final extension. Staff states that the Office of the Public Counsel does not oppose the extension request. The requested extension will move the Day 150 requirement from April 24, 2017, to May 9, 2017.

Finding the request to be reasonable, the Commission will grant the final extension request and accept the updated Small Utility Rate Case Timeline submitted with the *Motion for Extension*.

**THE COMMISSION ORDERS THAT:**

1. Staff's April 20, 2017 *Motion for Extension* is granted. The updated Small Utility Rate Case Timeline is accepted.
2. This order shall be effective when issued.
