On May 2, 2018, the Commission issued its *Report and Order* with a May 28, 2018 effective date. On May 22, 2018, the Home Builders of St. Louis and Eastern Missouri (“HBA”) filed an *Application for Rehearing*, as authorized by Section 386.500, RSMo 2016.

The Commission will direct Missouri-American Water Company to submit a response to HBA’s application. The Commission will also set a deadline for those parties wanting to file a response.

**THE COMMISSION ORDERS THAT:**

1. No later than June 1, 2018, Missouri-American Water Company shall file a response to HBA’s *Application for Rehearing*.
2. Parties may file a response to HBA’s *Application for Rehearing* no later than June 1, 2018.
3. This order shall be effective when issued.
