ORDER SETTING DISCOVERY CONFERENCE

On March 12, 2018, the Staff of the Commission filed a Motion to Compel Discovery. Commission Rule 240-2.090(8)(B) states one of two requirements that must be completed before the Commission will entertain any discovery motions:

If the issues remain unresolved after the attorneys have conferred in person or by telephone, counsel shall arrange with the commission for an immediate telephone conference with the presiding officer and opposing counsel. No written discovery motion shall be filed until this telephone conference has been held.

The Commission will order Staff to contact the other parties to arrange a conference call with the regulatory judge on March 13, 2018. Interveners should be invited to participate in the conference call as some of them have expressed concern with being included in the discovery process.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall arrange a conference call with the parties for March 13, 2018, with the regulatory judge.

2. This order shall be effective when issued.
