ORDER GRANTING UNOPPOSED EXTENSION REQUEST

A complaint has been filed, and subsequently a motion for summary disposition made. The Commission has granted previous unopposed extensions to all parties to file responses to the motion, as the Carl R. Mills Water Service is involved in multiple cases before the Commission.

On April 29, 2022, Carl R. Mills Water Service filed a *Stipulated Motion for Extension of Time to Respond to Motion for Summary Disposition* which requests an extension for responses to the motion for summary disposition to July 1, 2022. The extension motion states that complainant consented to the extension request.

The Commission finds the unopposed request to be reasonable and will grant the extension of time for Carl R. Mills Water Service to file its response. The Commission will also extend the deadline for other parties wishing to respond to Mr. Morgan’s motion for summary determination.

THE COMMISSION ORDERS THAT:

1. Carl R. Mills Water Service shall file a response to the motion for summary determination, or a request for further extension, on or before July 1, 2022.
2. Any other party may file a response to the motion for summary determination, or request for further extension, on or before July 1, 2022.
3. This order shall be effective when issued.
