ORDER GRANTING UNOPPOSED EXTENSION REQUEST

Issue Date: January 31, 2022

Effective Date: January 31, 2022

A complaint has been filed, and subsequently a motion for summary disposition made. In granting the parties' first request for extension filed on December 1, 2021, the Commission directed a response from Carl R. Mills Water Service d/b/a Carl Richard Mills to Complainant's motion for summary determination by February 7, 2022. The Commission permitted other responses by the same date.

On January 28, 2022, Carl R. Mills Water Service filed a second *Stipulated Motion for Extension of Time to Respond to Motion for Summary Disposition* which requests a second extension to March 21, 2022. March 21, 2022, is the same date for submission of responses to Staff's recommendation in a separate Commission file to transfer ownership of the subject water system, WM-2022-0144. The complainant consented to the extension request.

The Commission finds the unopposed request to be reasonable and will grant the extension of time for Carl R. Mills Water Service to file its response. The Commission will

also extend the deadline for other parties wishing to respond to Mr. Morgan's motion for summary determination.

THE COMMISSION ORDERS THAT:

1. Carl R. Mills Water Service shall file a response to the motion for summary determination on or before March 21, 2022.
2. Any other party wishing to file a response to the motion for summary determination shall do so on or before March 21, 2022.
3. This order shall be effective when issued.
