**ORDER DIRECTING FILING OF A PROPOSED PROCEDURAL
CONFERENCE DATE OR PROCEDURAL SCHEDULE**

Issue Date: March 7, 2022

Effective Date: March 7, 2022

On December 16, 2021, Ralph Rudolph filed a formal complaint with the Commission against Missouri-American Water Company (MAWC). On January 18, 2022, MAWC filed its *Answer to Complaint*. On March 1, 2022, the Staff of the Commission (Staff) filed its investigative *Staff Report and Recommendations*.

The Commission will direct the parties to collaborate and propose a date, time, and location for a procedural conference or, if the parties agree that a procedural conference is not necessary, a joint proposed procedural schedule shall be filed instead.

THE COMMISSION ORDERS THAT:

1. Staff shall coordinate with the parties and file, no later than March 18, 2022, a proposed date and time for a procedural conference. Should the parties agree that a procedural conference is unnecessary, Staff shall file, no later than March 18, 2022, a joint proposed procedural schedule in lieu of a procedural conference. Regardless of whether the filing proposes a procedural conference or a procedural schedule, it shall state the parties' preference as to whether the procedural conference or, if proposing a

procedural schedule, the evidentiary hearing, shall be held in person (and, if so, the proposed location in St. Louis County), via WebEx video/teleconference, or a hybrid of in-person/WebEx.

2. This Order shall be effective when issued.
