On April 15, 2022, the Staff of the Commission (Staff) filed complaints against Northgate MHP Lindale, LLC, d/b/a Northgate Manufactured Home Community (Northgate Lindale). Northgate Lindale filed its answer, and the Commission directed the submission of a proposed procedural schedule on or before July 5, 2022.

On July 5, 2022, Staff requested an extension of time to file a proposed schedule as the parties have been in communication with each other regarding a possible resolution.
