MOTION FOR EXTENSION

COMES NOW the Staff of the Missouri Public Service Commission (Staff), Hillcrest Utility Operating Company, Inc. (Hillcrest), and the Office of the Public Counsel (OPC), by and through counsel, and for their *Motion for Extension* in these matters hereby state:

1. The Commission on July 12 issued a *Report and Order* in the above-referenced matters. On July 14 the Commission issued an order directing the parties to file a detailed reconciliation regarding the dollar value and rate or charge impact of the contested issues in these matters, resolved by the Commission's *Order*.
2. Staff created a *Reconciliation* based on the Commission's directives to the best of its ability, which the other parties to these matters are presently reviewing. Due to the detailed nature of the Commission's request, the parties would like to collectively request an extension of the filing requirement to July 29, 2016.

WHEREFORE, Staff prays that the Commission will approve this *Motion for Extension* and order the filing date be extended to require the *Reconciliation* be filed no later than Friday July 29; and grant such other and further relief as the Commission considers just in the circumstances.
