ORDER EXTENDING TIME TO FILE COMPLIANCE TARIFFS AND RECONCILIATION

Issue Date: February 14, 2018 Effective Date: February 14, 2018

Indian Hills Utility Operating Company, Inc. ("Indian Hills") filed a *Motion for Extension of Time to File Reconciliation and Tariff Sheets*¹ ("motion") from February 14, 2018, to February 21, 2018. In support, Indian Hills cites among other things, personnel availability and workload. Indian Hills also represents that the motion carries the concurrence of the Commission's staff ("Staff") and the Office of the Public Counsel ("OPC").

No tariffs are pending, so no date is approaching for the expiration of any suspension of tariffs. The regulation governing this case provides that:

[T]he commission's decision and order regarding the case shall be issued and effective no later than eleven (11) months after the case was opened. [³]

Eleven months after the case was opened will be March 4, 2018, and several more events must occur. Parties may file responses to the reconciliation and compliance tariffs. The Commission's rulings on the reconciliation and compliance tariffs will be subject to motions for reconsideration or applications for rehearing. If the Commission approves the compliance tariffs, the effective date of such an order must allow a meaningful time for the

filing of an application for rehearing. Therefore, granting the motion will carry this case beyond eleven months.

But the 11-month date is for the benefit of Indian Hills. The purpose of the 11-month date is to resolve this case within the same time as a case that starts with the filing of tariffs under Section 393.150.1, RSMo 2016. Therefore, the only prejudice from granting the motion is to the movant, Indian Hills. The procedural schedule as agreed by the parties,⁴ and ordered by the Commission, ⁵ sets no other dates. The Commission will grant the motion.

THE COMMISSION ORDERS THAT:

- 1. The Motion for Extension of Time to File Reconciliation and Tariff Sheets is granted.
- 2. The reconciliation and compliance tariffs shall be filed no later than February 21, 2018.
 - 3. This order shall be effective when issued.
