On July 19, 2017, Missouri Industrial Energy Consumers (MIEC), Missouri Department of Economic Development – Division of Energy (DE), Utility Workers Union of America Local 335 (UWUA), and the City of Joplin, Missouri (Joplin), filed timely applications to intervene in Missouri-American Water Company's request for a general rate increase. On July 20, 2017, the Commission issued an order setting a July 24, 2017 deadline for the filing of responses to MIEC's, DE's, UWUA's, and Joplin's applications. No responses were received. Therefore, the Commission will consider the unopposed applications to intervene.

Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant the applications to intervene.
