ORDER REVISING HEARING SCHEDULE

The Commission previously issued an order setting Friday, March 2, 2018, as the start date for the evidentiary hearing in this matter. Since then, Missouri-American Water Company (MAWC) and the City of Jefferson City filed a *Stipulation Jefferson City Issues*, which resolved all but one of the issues set to be heard on Friday, March 2, 2018. The Commission will therefore cancel tomorrow’s hearing and reschedule the Allocation of Cost issue for Tuesday, March 6, 2018.

A *Stipulation and Agreement* was filed on March 1, 2018. The Commission will hear statements from the parties on the *Stipulation and Agreement* on Monday, March 5, 2018 before hearing testimony on the remaining contested issues.


THE COMMISSION ORDERS THAT:

1. The start date for the evidentiary hearing, as previously ordered by the Commission in its September 6, 2017 *Order Scheduling Evidentiary Hearing and Setting Procedural Schedule*, and revised in the Commission’s February 23, 2018 order is further revised to now begin on Monday, March 5, 2018, at 9:00 a.m. At that time, the Commission shall hear presentations from the parties on the agreements submitted for the

Commission's approval. The Commission will then hear testimony on the Lead Service Line Replacement Issue.
