**PROPOSED DATE FOR HEARING ON BEHALF OF THE STAFF OF THE  
MISSOURI PUBLIC SERVICE COMMISSION AND  
MISSOURI AMERICAN WATER COMPANY**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through undersigned counsel, on behalf of itself and Missouri American Water Company (“MAWC”), respectfully states:

1. On November 10, 2020, the Commission issued its *Order Continuing Hearing and Directing Filing*, in which it continued the evidentiary hearing scheduled in this matter for November 19, 2020, and ordered the Staff, MAWC, and Claude Scott (“Complainant”) to propose a new hearing date within the period from December 14, 2020 through January 2021.
2. That same day, Staff contacted MAWC and Complainant via email, proposing January 6, 2021 as a date for the evidentiary hearing.
3. Staff followed up with MAWC and Complainant on November 23, 2020 via email. MAWC responded that same day, and agreed with Staff’s proposed date.
4. Staff again asked for Complainant to confirm the proposed date, via email, on November 24, 2020.

5. Staff again emailed Complainant today, November 30, 2020, and reminded him of today's filing. In addition, Staff called Complainant at the number listed in his *Complaint*; he did not pick up, and Staff was unable to leave a voice message.

6. At the time of this filing, Complainant has yet to respond whether he agrees or disagrees with Staff's proposed date of January 6, 2021. Staff and MAWC have agreed that January 6, 2021 would be the ideal date to hold the evidentiary hearing in this matter.

**WHEREFORE**, Staff and MAWC respectfully request that the Commission accept this response, and order that the evidentiary hearing in this matter be held on January 6, 2021.
