ORDER DIRECTING EXTENSION

Issue Date: July 29, 2022

Effective Date: July 29, 2022

A complaint has been filed, and subsequently a motion for summary disposition made. The Commission has granted previous unopposed extensions to all parties to file responses to the motion, as the Carl R. Mills Water Service is involved in multiple cases before the Commission.

One of the companion cases is File No. WM-2022-0144. That case is a potential transfer of ownership of the Carl R. Mills Water Service. In File No. WM-2022-0144, the Commission recently granted a requested extension of time for the Staff of the Commission (Staff) to file its recommendation. The extension gives Staff until August 11, 2022, to file its recommendation in the transfer of ownership case.

In pursuit of the settlement that could occur in the complaint case due to resolution of the transfer case, the parties have requested and received several extensions since July 26, 2021. The parties' most recent extension, issued April 29, 2022, set a due date for replies of July 1, 2022. No parties responded by the due date, nor requested a further extension.

Because the transfer case may negate or settle the complaint case, the Commission will on its own motion direct a further extension for the parties' responses due in this complaint file, WC-2021-0223. The Commission will also extend the deadline for other parties wishing to respond to Mr. Morgan's motion for summary determination.

THE COMMISSION ORDERS THAT:

1. Carl R. Mills Water Service shall file a response to the motion for summary determination, or a request for further extension, on or before November 1, 2022.
2. Any other party may file a response to the motion for summary determination, or request for further extension, on or before November 1, 2022.
3. This order shall be effective when issued.
