On March 1, 2022, the Staff of the Commission (Staff) filed its *Staff Report and Recommendations* regarding Ralph Rudolph's formal complaint with the Commission against Missouri-American Water Company (MAWC).

On March 8, 2022, MAWC filed a *Motion for Extension Related to Response to Staff's Report and Recommendations* in which it requested the Commission allow it until March 30, 2022, to respond to Staff's report, "given the more global nature of many of Staff's recommendations." MAWC states that Staff and the Office of Public Counsel do not object to the extension and that Mr. Rudolph did not respond when asked about the extension.

The Commission finds MAWC's request reasonable and will the extension.

THE COMMISSION ORDERS THAT:

1. MAWC's motion for an extension of time to file its response to *Staff's Report and Recommendations* is granted. MAWC shall be allowed until March 30, 2022, to file its response.
