**ORDER SUSPENDING PROCEDURAL SCHEDULE AND DIRECTING
FILING OF A MONTHLY STATUS REPORT**

On July 28, 2022, the Staff of the Commission (Staff) filed a motion to suspend the procedural schedule. The motion states that because the Commission just granted Staff's motion to compel entry onto land for inspection on July 27, 2022, Staff will need additional time to conduct the site visit and may need to issue additional data requests. Pursuant to the procedural schedule, Staff's direct testimony is currently due July 29, 2022. The Commission will grant Staff's motion and suspend the procedural schedule and cancel the currently set hearing date. The Commission will also order Staff to file a monthly status report.

THE COMMISSION ORDERS THAT:

1. The procedural schedule is suspended and the evidentiary hearing is canceled.
2. Staff shall file a monthly status report on this matter no later than the 30th of each month, beginning on August 30, 2022.

3. This order is effective when issued.
