ORDER DIRECTING RESPONSE TO MEDIATION REQUEST

On April 22, 2022, the Staff of the Missouri Public Service Commission (Staff) filed a complaint with the Commission against I-70 Mobile City, Inc. d/b/a I-70 Mobile City Park. On April 25, 2022, the Commission issued its *Order Giving Notice of Contested Case Filing and Directing an Answer*, which also explained how to request mediation. Mediation is an informal method of dispute resolution in which the parties voluntarily agree to participate, if mediation is unsuccessful the case returns to the contested case track. No party relinquishes any rights by agreeing to participate in mediation. I-70 Mobile City Park filed a request for mediation on May 10, 2022.

The Commission will order Staff to reply to whether it agrees to mediation of the formal complaint.

THE COMMISSION ORDERS THAT:

1. No later than May 20, 2022, Staff shall respond to I-70 Mobile City Park’s mediation request and state whether Staff agrees to mediation.

2. This order is effective when issued.
