ORDER SETTING PROCEDURAL CONFERENCE

On February 28, 2023, the Commission issued an order in this matter directing the Staff to file a proposed procedural schedule no later than March 29, 2023. On March 28, the Staff of the Commission filed its proposed procedural schedule. The proposed schedule requests a hearing date on which the Commission's facilities are not available to accommodate an evidentiary hearing, and does not address the location of the hearing.

Commission Rule 20 CSR 4240-2.070(15)(E) prescribes the procedures in small formal complaint cases, and states:

Any hearing, unless otherwise agreed to by the parties, shall be held in the county, or a city not within a county, where the subject utility service was rendered or within thirty (30) miles of where the service was rendered. The regulatory law judge may allow any party, witness, or attorney to participate in the hearing by telephone.

The Commission will schedule a conference to discuss where the evidentiary hearing will be held, whether an evidentiary hearing via WebEx is appropriate, and any

other matters relevant to procedures in this case. All parties must appear either by WebEx or by telephone.

THE COMMISSION ORDERS THAT:

1. A procedural conference is scheduled for Wednesday, April 12, at 1:00 p.m. to be held by WebEx. The WebEx meeting number is 2457 984 1305. The telephone number to participate is 1-855-718-6621, and the password to attend is 0166.

2. Any party wishing to appear at the procedural conference by telephone only may do so by calling 1-855-718-6621 and inputting meeting number 2457 984 1305 at the time of the conference.

3. This order shall be effective when issued.
