On behalf of the United Way of Greater St. Louis, I am writing in support of Spire and its commitment to providing reliable natural gas to the residents of the St. Louis region and eastern Missouri.

United Way of Greater St. Louis serves seven counties in eastern Missouri, helping children, families and seniors live their best possible lives. Far too many of those we support struggle to meet their basic needs and face tough decisions every day, such as paying rent, buying food, affording life-saving medicine, or heating and cooling their homes. In St. Louis City and County, more than 56 percent and 40 percent of households, respectively, do not have the monthly income to meet these basic expenses. Losing access to affordable natural gas could mean an extra financial burden on families and more tough decisions, like whether a parent can give their child a warm bath or a senior can make a hot meal.
