ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On December 16, 2021, Ralph Rudolph filed a formal complaint with the Commission against Missouri-American Water Company (MAWC).

On December 17, 2021, the Commission directed the Staff of the Commission (Staff) to investigate the complaint and file a report or a request for an extension of time within which to file the report no later than February 15, 2022.

On February 14, 2022, Staff filed *Staff's Request for Extension of Deadline to File Report and Recommendations*, requesting that the deadline to file its report be extended to no later than February 22, 2022. Staff states in its request that all parties have agreed to the extension.

The Commission finds the motion reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of the deadline to file its report and recommendation is granted. Staff shall file its report and recommendation no later than February 22, 2022.
