## ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On October 25, 2022, Michelle Goad filed a formal complaint with the Commission against Missouri-American Water Company (MAWC).

On December 8, 2022, the Commission directed the Staff of the Commission (Staff) to investigate the complaint and file a report or a request for an extension of time within which to file the report no later than January 6, 2023.

On January 6, 2023, Staff filed *Staff's Request for Additional Time to File a Recommendation*, requesting that the deadline to file its report, or a pleading stating when it can file the report, be extended to no later than February 5, 2023. The other parties to this matter have no objection to the request.

The Commission finds the motion reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of the deadline to file its report and recommendation is granted. Staff shall file its report and recommendation, or a pleading stating when it expects to file the report, no later than February 5, 2023.

2. This Order shall be effective when issued.
