On December 21, 2016, the Commission issued its *Order Directing Notice and Setting Dates* in this case. The order set a deadline of February 10, 2017, for the Staff of the Missouri Public Service Commission (Staff) to file a recommendation regarding Missouri-American Water Company’s application. On February 10, 2017, Staff filed a request for an extension.

Staff states that they are still in the process of seeking and reviewing information. Further, Staff states that Missouri-American Water Company has no objection to the extension. Therefore, the Commission will grant the extension.

1. The *Motion for Extension* filed by the Staff of the Missouri Public Service Commission on February 10, 2017 is granted.
2. The Staff of the Missouri Public Service Commission shall file its recommendation in this matter no later than March 13, 2017.
