3 JUDGE WOODRUFF: Well, welcome to the
4 prehearing conference today.

5 There are actually three -- three prehearings
6 scheduled in three different cases: XT-2003-0227,
7 which involves Tariff of NOS Communications, Inc.; also
8 IT-2003-0228, which involves the Tariff of Affinity
9 Network, Inc.; and XT-2003-0229, which involves the
10 Tariff of NOSVA Limited Partnership.

11 And what I propose to do is to have all
12 three prehearings concurrently. So we'll begin with
13 entries of appearance.

2 discussions. And I will go ahead and do an order doing
3 the consolidation on the Commission's own motion. And
4 we'll be expecting your procedural schedule.
