MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and moves for the Missouri Public Service Commission ("Commission") to cancel the certificate of service authority of Multiband, Inc. ("Multiband"). For its Motion, Staff states as follows:

1. On February 9, 2007, the Commission granted Multiband a certificate of service authority to provide shared tenant services at Jefferson Arms Apartments, located in Saint Louis, Missouri, in Case No. ZA-2006-0346.

2. On March 18, 2013, Staff received Multiband's Statement of Revenue for calendar year 2012, in which it states it no longer wishes to retain its certificate of service authority. (See Highly Confidential Attachment A).

3. Because Multiband requested cancellation of its certificate and is not providing services in Missouri to the best of Staff's knowledge, information and belief, Staff recommends the Commission cancel the certificate.

4. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5, RSMo (Supp. 2012), which provides "Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

5. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

6. Multiband is current on the payment of fiscal year assessments, but has not submitted its 2012 calendar year annual report.

7. Staff is not aware of any other matter that the Commission's decision in this case will affect, or be affected by.

WHEREFORE, Staff recommends that the Commission cancel the certificate of service authority of Multiband, Inc., to provide shared tenant services.
