**STAFF RECOMMENDATION FOR APPROVAL OF TARIFF SHEETS**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Staff Recommendation for Approval of Tariff Sheets* states the following:

1. On March 11, 2015 the Commission issued its *Order Granting Certificate of Convenience and Necessity and Granting Waiver* (Order) in this case, which became effective on April 10, 2015, and in which it granted Missouri-American Water Company (MAWC) a certificate of convenience and necessity and authority to provide service in the Redfield subdivision in Cole County. As a part of its Order, the Commission authorized and directed MAWC to file tariff sheets consistent with the Order, which reflect the addition of the subject service area.

2. On March 13, 2015, MAWC submitted tariff sheets intended to comply with the above-referenced Commission Order, and the filing was assigned number YW-2015-0272 by the Commission's electronic filing system. The subject tariff sheets bore an issue date of March 13, 2015, and an effective date of April 12, 2015.

3. The Staff has reviewed MAWC's tariff filing, and states to the Commission that it believes the subject tariff sheets are in compliance with the above-referenced

Commission Order. Jim Merciel of the Commission's Water & Sewer Department performed the review of the subject tariff sheets on behalf of the Staff.

4. Based upon the above, the Staff recommends that the Commission issue an order approving the following tariff sheets to be effective for service rendered on and after April 12, 2015:

- 2<sup>nd</sup> Revised Sheet No. RT 1.2 canceling 1<sup>st</sup> Revised Sheet No. RT 1.2 – the rate sheet
- 3<sup>rd</sup> Revised Certificated Area Table of Contents Sheet A cancelling 2<sup>nd</sup> Revised Certificated Area Table of Contents Sheet A – table of contents for service areas
- Original Certificated Area Sheet No. CA 3.2 – the Redfield map
- 1<sup>st</sup> Revised Certificated Area Sheet No. CA 3.1 canceling Original Certificated Area Sheet No. CA 3.1 – written description of Jefferson City and Redfield.

**WHEREFORE**, the Staff respectfully requests that the Commission issue an order approving the above-referenced tariff sheets, consistent with the Staff's recommendations presented herein.




