On June 7, 2018, the Carl Mills Trust filed an application for a certificate of convenience and necessity seeking authority to install, own, acquire, construct, operate, control, manage and maintain the water system in Carriage Oaks Estates. The Commission published notice of the application and set an August 6, 2018, deadline for the Commission's Staff to file a pleading specifying a date when it would file a recommendation. Staff timely filed pleading stated that they anticipate filing a recommendation by September 20, 2018. The Commission will establish that date for Staff to file its recommendation.
