COMES NOW, the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for this *Motion for Extension* of the Staff Investigation Report filing deadline, states the following:

1. On July 3, 2018, Thirty and 141, L.P. (Complainant), filed its Complaint against Respondent Missouri-American Water Company (MAWC or Company).
2. On July 16, 2018, the Commission directed Staff to conduct an investigation of the complaint and file a report of its investigation along with any recommendations. The Commission gave a deadline of September 6, 2018 to complete this investigation.
