At a pre-hearing conference held on January 28, 2015,
the following procedural schedule was agreed upon by the parties:

March 20, 2014	- All parties' reply/rebuttal testimony due.
April 1, 2015	- Staff's and Intervenors' surrebuttal testimony due.
Live at Evidentiary Hearing	- Company Rejoinder.
April 8-9, 2015 ¹	- Evidentiary Hearings.
April 21, 2015	- Initial briefs due.
May 1, 2015	- Reply briefs due
May 27, 2015	- Target date for issuance of Proposed Order.
June 8, 2015	- Any notices of appeal and memoranda on appeal due.
June 17, 2015	- All reply memoranda on appeal due/suspension period ends.
July 17, 2015	- Commission order due.

The date, location and time of the evening hearing for public comment will be set at a later date.

This schedule includes an additional 30 days which makes July 17, 2015 the 180th day of rates being suspended. The parties also agreed that discovery responses are due not later than the seventh business day after receipt of the request through March 2, 2015. After March 2, 2015, discovery responses are due from all parties not later than the fifth business day after receipt of the request. All testimony is to be served electronically on all parties on the date of the filing, in addition to first-class mail.
