ORDER DENYING REQUEST TO CONTINUE EVIDENTIARY HEARING

On the evening of July 11, 2023, Complainant Dr. Sarah Nangle attempted to contact the presiding officer and counsel for the other parties in this matter, via e-mail, to request that the evidentiary hearing in this matter be rescheduled, citing discovery issues. The e-mail address of the presiding officer was incorrect. Counsel for the Staff of the Commission (Staff) forwarded Dr. Nangle's e-mail to the presiding officer on July 12, 2023. Counsel for both Staff and Respondent Missouri-American Water Company oppose Dr. Nangle's request.

On March 31, 2023, the Commission issued its *Order Establishing Procedural Schedule* in this matter. As part of the order, the Commission set July 21, 2023, as the date for the evidentiary hearing and June 2, 2023, as the deadline for discovery among the parties. Accordingly, any discovery issues should have been brought to Commission's attention by that deadline under the provisions of Commission Rule 20 CSR 4240-2.090.

The Commission will deny Complainant's request.

THE COMMISSION ORDERS THAT:

1. Complainant's request that the evidentiary hearing in this matter be rescheduled/continued beyond July 21, 2023, is denied.
