**ORDER SETTING TIME FOR RESPONSES**

On November 23, 2022, I-70 Mobile City, Inc. d/b/a I-70 Mobile City Park filed a motion for summary determination. Commission rule 20 CSR 4240-2.117(1) allows not more than 30 days in which a party may file a response to that motion. On December 7, 2022, the Commission’s Staff (Staff) filed a motion to stay the 30-day deadline to file a response to the summary determination motion in order to conduct discovery.

On December 8, 2022, I-70 Mobile City Park filed a motion for a protective order requesting that the Commission stay any discovery until I-70 Mobile City Park’s summary determination motion is ruled upon.

The Commission will set a time for any responses to Staff and I-70 Mobile City Park’s motions.

**THE COMMISSION ORDERS THAT:**

1. Any responses to *Staff Motion to Stay Response Deadline to Motion for Summary Determination Pursuant to 20 CSR 4240-2.117(1)(D)* and I-70 Mobile City Park's *Motion for Protective Order* shall be filed by December 13, 2022, at noon.
2. This order is effective when issued.
