**ORDER STAYING RESPONSE TIME**

Issue Date: December 21, 2022 Effective Date: December 21, 2022

On December 7, 2022, the Commission’s Staff (Staff) filed a motion to stay the 30-day deadline to file a response to I-70 Mobile City Park’s summary determination motion in order to conduct discovery, pursuant to Commission Rule 20 CSR 4240-2.117(1)(D). In support of its motion, Staff states that it cannot answer the motion without conducting additional discovery. The Commission set a time for responses to Staff’s stay request, and I-70 Mobile City Park filed a timely response.

The Commission’s order concerning discovery via entry onto land is currently pending before the Cole County Circuit Court. Accordingly, the Commission finds it appropriate to stay the summary determination motion pending a resolution of Cole County Circuit Court case 22AC-CC05836.

**THE COMMISSION ORDERS THAT:**

1. Staff’s request to stay I-70 Mobile City Park’s summary determination motion, is granted. The Commission will set a new deadline for responses after the resolution of Cole County Circuit Court case 22AC-CC05836.

2. This order is effective when issued.
