ORDER GRANTING STAFF'S REQUEST FOR CORRECTION OF SEGES DEFICIENT APPLICATION AND NEW DATE FOR STAFF RECOMMENDATION OR STATUS FILING

Issue Date: August 14, 2008 Effective Date: August 14, 2008

On June 19, 2008, Seges Partners Mobile Home Park, L.L.C. ("Seges"), filed an application with the Missouri Public Service Commission. It requests a certificate of convenience and necessity to operate a water system.

The Commission issued notice of Seges' application to the public and set a date for the filing of intervention requests. The Commission received no intervention requests. Thereafter the Commission ordered its Staff (hereafter "Staff") to file a recommendation or status report no later than August 20.

On August 13, 2008, Staff filed Staff's Request for Correction of Seges Deficient Application and New Date for Staff Recommendation or Status Filing. Staff stated that an applicant for a certificate of convenience and necessity to operate a water system is required to file a plat map showing the area to be served, and a feasibility study regarding how the service is proposed to be offered.¹ Staff avers that Seges has failed to submit that information; therefore, Staff states that it is unable to provide a full and fair recommendation

by August 20. Staff asks the Commission to order Seges to correct the deficiencies in its

application by a date certain, and to extend Staff's deadline to file a Recommendation or

Status Report.

A review of the Commission's Electronic Filing Information System (hereafter "EFIS")

confirms Staff's allegation that Seges has not yet filed a plat map or feasibility study.

Therefore, the Commission will order Seges to file that plat map and feasibility study, and

will suspend Staff's obligation to file a Recommendation until after Seges has filed that plat

map and feasibility study. The Commission will establish a new date for Staff to file its

Recommendation or Status Report after Seges files the required information.

IT IS ORDERED THAT:

1. Staff's Request for Correction of Seges Deficient Application and New Date

for Staff Recommendation or Status Filing is granted.

2. Seges Partners Mobile Home Park, L.L.C. shall file the above-cited

information no later than September 15, 2008.

3. This order shall become effective immediately upon issuance.
