### ORDER APPROVING TARIFF

Issue Date: August 31, 2009 Effective Date: September 9, 2009

On August 10, 2009,<sup>1</sup> Whiteside Hidden Acres, L.L.C, (hereafter "Whiteside") filed tariff sheets, effective September 9, to allow it to provide water service in Hickory County, Missouri. Whiteside filed the tariff as ordered by the Commission on July 1, in the Commission's Order Approving Unanimous Stipulation and Agreement and Granting Certificate of Convenience and Necessity.

The Commission ordered its Staff to file a recommendation no later than August 28. It also permitted, but did not require, OPC to respond no later than August 28.

The Commission's Staff filed its Recommendation on August 27, stating that Staff recommended that the Commission approve the submitted tariff filing. OPC did not respond.

The Commission has authority to approve tariff sheets pursuant to Sections 393.140(11) and 393.150, RSMo. Also, Section 393.130.1, RSMo, requires that charges for sewer service be just and reasonable. The Commission's July 1 order

approving the parties unanimous disposition agreement means that the Commission found the rates agreed upon in that agreement to be just and reasonable.

The Commission has reviewed the tariff sheets and Staff's recommendation. The Commission finds that the tariff sheets conform to the Commission's July 1 order, and should be approved to become effective on September 9.

## THE COMMISSION ORDERS THAT:

1. The tariff filed by Whiteside Hidden Acres, L.L.C. on August 10, 2009, and assigned tariff number YW-2010-0079, is approved to become effective on September 9, 2009. The tariff approved is:
