STAFF RECOMMENDATION TO APPROVE TARIFF

COMES NOW the Staff of the Missouri Public Service Commission, and, for its Staff Recommendation to Approve Tariff, respectfully states:

- 1. On January 20, 2015, TUK LLC (TUK) filed an application for CCN, and on May 22, 2015, Staff filed a recommendation, which was corrected on May 28, 2015, that asked the Commission to approve the application subject to conditions.
- 2. TUK, Staff, and OPC entered into a stipulation and agreement on October 7, 2015, and on October 22, 2015, the Commission filed its *Order Approving Stipulation and Agreement and Granting Certificate of Convenience and Necessity.*
- 3. In accordance with the granting of the CCN, TUK filed a New Tariff, YS-2016-0141, on December 2, 2015. Staff reviewed the tariff and requested some changes, which were made and submitted on December 24, 2015.
- 4. Based on Staff's review of the New Tariff and Substitute Tariff sheet, Staff recommends approval of the YS-2016-0141 tariff.

WHEREFORE, Staff recommends the Commission either issue an order approving the proposed tariff as filed by TUK on December 2 and December 24, 2015, to go into effect January 1, 2016, or to allow it to go into effect by operation of law that same date.
