On April 21, 2017, Missouri-American Water Company (“MAWC”) filed applications with the Missouri Public Service Commission (“Commission”) requesting that the Commission grant it Certificates of Convenience and Necessity to install, own, acquire, construct, operate, control, manage and maintain a water and sewer system in St. Louis County, Missouri. On June 20, 2017, the Staff of the Commission filed a recommendation to approve the applications subject to a number of conditions. The Commission will direct MAWC to file a response addressing the conditions in the Staff recommendation.

THE COMMISSION ORDERS THAT:

1. Missouri-American Water Company shall respond to the Staff recommendation, specifically addressing the conditions set out therein, no later than June 30, 2017.
2. Any other party wishing to respond to the Staff recommendation shall do so no later than June 30, 2017.

3. This order shall be effective when issued.
