The Staff of the Missouri Public Service Commission was directed to investigate and respond, and filed a recommendation on October 11, 2018, recommending the Commission approve the application. Derald Morgan, Rick and Cindy Graver, William and Gloria Phipps, and David Lott oppose the application. In order to discuss a procedural schedule and possible settlement of this matter, the Commission will set a prehearing conference. In addition, for the convenience of the parties, they may appear by telephone as set out below.

THE COMMISSION ORDERS THAT:

1. The parties shall appear at a prehearing conference to be held on November 8, 2018 at 1:30 p.m.
2. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who
